

DEPOSIT REQUIREMENTS – WEDDINGS & FUNCTIONS

Securing Deposit

Upon reservation, a 50% deposit of total cost is payable. All monies are non-refundable once paid unless the reservation date can be filled by other another wedding / function reservation or spa reservations. Full settlement by the client is required 7 calendar days prior to the date of the event.

Sponsored Bar Deposit

Payment of the agreed sponsored bar amount is payable 24 hours prior to the date of the event. Should the client wish to increase the sponsored amount, immediate settlement of the increased amount will apply.

Linen Deposit

R1000.00 deposit is required if candles are used on the tables. The deposit may be used for specialized dry cleaning should this be required and possible linen replacement in case of burns. Only non-drip candles will be allowed.

The responsibility rests with the Groom, Bride or their function representative to confirm the condition of all the linen used on the day of the event prior to commencement of the event. Damage assessment will be executed within 48 hours after the event. The deposit or part thereof will be refunded within 7 days after the date of the event.

Breakages Deposit

An additional deposit of R1000.00 is required for any breakages or damages. In the unfortunate event of breakages or damages, replacement costs will be deducted from this deposit. This deposits or part thereof will be refundable within 7 days after the date of the event.



DEPOSIT REQUIREMENTS – SPA

Securing Deposit

Upon reservation, a 50% deposit of total cost is payable within 72 hours of the date on which the reservation is made. The balance is only payable on the date of the reservation. Should the deposit (72 hours) not be received in time, the reservation may be automatically cancelled without notification.

Cancellation

- Should a cancellation be made 21 days to 8 days prior to the reservation date, an administration fee of R150.00 per person is payable. The deposit or part thereof will be refunded within 7 days after the cancellation.
- Should a cancellation be made within 7 days of the reservation date, or on the reservation date, the full deposit amount will be forfeited unless the reservation can be filled by another. In this case the administration fee of R150.00 per person will apply.
- Should the reservation date be changed / postponed 21 days to 8 days prior to the reservation date, an administration fee of R150.00 per person is payable.
- Should the reservation date be changed / postponed within 7 days of the reservation date, or on the reservation date, the full deposit amount will be forfeited unless the reservation can be filled by another. In this case the administration fee of R150.00 per person will apply.

RIGHT OF ADMISSION AND INDEMNITY

- Visitors to Bayete enter at their own risk and wave all rights and claims he/she may now or at any other time in the future have against Bayete and releases Bayete, it's management, owners, members, employees, agents, servants, representatives and contractors from all liabilities.
- Visitors agree, indemnify and hold harmless Bayete from any personal injury, death, damage or loss of any kind suffered or sustained by any visitor.
- No offensive behaviour will be permitted. Children under 12 must be supervised by an Adult at all times.
- No alcoholic beverages are allowed to be brought into Bayete.
- Visitors are welcome to Bayete by appointment, invitation and reservation only.
- Management reserves the right of Admission and the right to evict any person for not abiding by the Rights of Admission.

TERMS & CONDITIONS

Bayete reserves the right to cancel any booking forthwith and without liability on its part in the event of any damage to, or destruction of the venue by any act of God, or any other cause beyond the control of Bayete, which shall prevent it from performing its obligation in these circumstances.

All costs and disbursements including legal costs on the attorney and client scale incurred by Bayete in collecting or endeavouring to collect any amounts due in terms hereof are payable by the operator on demand including collection commission. The parties consents to the jurisdiction of the Magistrate's Court having jurisdiction in respect of all legal proceedings connected with this agreement, notwithstanding that the amount of the matter in dispute exceeds the court's jurisdiction.
